# INTERNATIONAL SHIPPING INSTRUCTIONS FOR CATEGORY B, **BIOLOGICAL SUBSTANCES**



**BIOLOGICAL SUBSTANCE CATEGORY B** 

According to IATA Packing Instruction 650 required for **UN3373**, Biological Substance, Category B:

The package must consist of the following 3 components

- 1. Leak-proof Primary receptacle (eg: Salmonella isolates slant tube with parafilm around the cap; Serum - bullet tube or screw cap vial with parafilm around the cap)
- 2. Leak-proof Secondary packaging; and
- 3. A rigid outer packaging of adequate strength for its capacity, mass, and intended use with one side with minimum dimension of 100mm x 100mm.
- Primary receptacles should be packed in secondary packaging in such a way as to prevent break, puncture or leakage of contents into the secondary packaging. Please use cushioning material to prevent such breakage under normal transport conditions.
- The secondary packaging should be secured in the rigid outer packaging with sufficient cushioning material to prevent receptacle from moving around during transport.

\*\*Please ensure that any leakage of contents will not compromise the integrity of the cushioning material or of the outer packaging.

\*\*\*An itemized list of contents must be enclosed between the secondary packaging and the outer packaging. This is also where you should enclose a completed GPLN submission form (available on the website -- quick link in quick reference column). We recommend placing these documents in a separate plastic sealable bag.

#### Labeling:

- Sender and recipient name and address must be on the outer packaging.
- Responsible person name and telephone number must be on the outer
- Clearly mark "Biological Substance, Category B" on the outside of the outer packaging. Text must be at least 6-mm high adjacent to the UN 3373 diamond-shaped marking. Please see IATA Packing Instruction 650 for further details.

# INTERNATIONAL SHIPPING INSTRUCTIONS FOR EXEMPT ANIMAL **SPECIMENS**

**EXEMPT** ANIMAL **SPECIMEN** 

## The package must consist of the following 3 components

- 1. Leak-proof Primary receptacle (eg: Serum bullet tube or screw cap vial)
- 2. Leak-proof Secondary packaging; and
- 3. A rigid outer packaging of adequate strength for its capacity, mass, and intended use with one side with minimum dimension of 100mm x 100mm.
- Primary receptacles should be packed in secondary packaging in such a way as to prevent break, puncture or leakage of contents into the secondary packaging. Please use cushioning material to prevent such breakage under normal transport conditions.
- The secondary packaging should be secured in the rigid outer packaging with sufficient cushioning material to prevent receptacle from moving around during transport.

Sufficient absorbent material must be packed between primary receptacle(s) and secondary packaging to absorb the entire volume present in the primary receptacles in case of leakage.

\*\*A completed GPLN submission form (available on the website -- link in quick reference column) must be enclosed between the secondary packaging and the outer packaging. We recommend placing this document in a separate plastic sealable bag.

#### Labeling:

- EXEMPT ANIMAL SPECIMEN must appear on the outer package
- Shipper and recipient information
